The Rulon Center

90 Day Intensive Outpatient Program consists of 3 group sessions per week, 3 hours and 15 minutes per session for 60 days. After initial 60 days in the program a client's treatment is reduced to 2 three hour group sessions weekly. Upon completion clients may participate in non-intensive treatment, including relapse prevention, men or women's track groups, or may opt for individual counseling to maintain recovery progress.
